This plan will be evaluated to determine if it is responsive to the goals of 31.7% for small business, 5% for small disadvantaged business concerns, 5% for women-owned concerns, 3% for service-disabled veteran-owned small business and, 3% for HUBZone small business concerns or an explanation as to why these goals cannot be met.”**

- 1) **Executive Summary is called out separately under Section L.17 (b). Please confirm that the Executive Summary will not be counted against the technical proposal's 50 page limit.**

*The Executive Summary will not be counted against the technical proposal page limit.*

- 2) **As this is a competitive procurement, will the Government consider removing the requirement for cost and pricing data (L.6)?**

*Considering the hierarchy of Federal Acquisition Regulation (FAR) 15.402, there is reasonable certainty that cost or pricing data will be necessary in ascertaining a fair and reasonable price hereunder. Therefore, the requirement will not be removed.*

- 3) **L.10 of the RFP requires that offerors submit a total compensation plan as part of their proposal. Should this be submitted as part of the cost proposal?**

*Yes.*

- 4) **There appears to be an inconsistency between the small business goals listed in sections L.18.f. (b) and M.3.f. (2). As the goals included in M.3.f. (2) are consistent with the Department of Defense Small Business Goals for FY11, can we assume that these are the correct goals?**

*The goals stated at M.3.f (2) are correct. Section L.18 (f) (b) has been adjusted accordingly.*

- 5) **As the total value of future tasking is unknown at this point, would the Government consider removing M.3.f. (1) (iv) from the solicitation?**

*The referenced section will not be removed.*

- 6) **M.3.f. (2) indicates that the Small Business Subcontracting Plan be in accordance with FAR 52.219-9, which expresses small business subcontracting dollars as a percentage of total subcontracted dollars. Therefore, should the chart included be changed to read "Current Standard % of Subcontracted Dollars"?**

*As noted in Question 4 above, the percentages are the Department of Defense Prime Contracting Goals as it relates to overall contract dollars. Changing the language of the chart as suggested would alter its intent.*

- 7) **Table 1 included in the cost proposal instructions includes lines for cost sharing. As cost sharing is not applicable to Tasks 1 and 2, can these lines be removed from the table?**

*As noted in the "Instructions for Preparing Cost Proposals for Contracts," the cost sharing lines should be used if applicable. As they are not applicable for Tasks 1 and 2, those lines may remain blank.*

- 8) **Should Table 1 information be provided for both Tasks 1 and 2, or is this summary information only?**

*The information must be provided for both Tasks 1 and 2.*

- 9) **Table 2 requests subcontracting cost at the SOW level. As the prime contractor is providing pricing at the task level only, is the same level requested for subcontractor costs?**

*Subcontract costs must be justified and fully disclosed in the cost volume.*

- 10) **We could not find the applicable NAICs code in the RFP document. Can the Government please provide the NAICs code?**

*541712*

- 11) **Can you tell me if these services are currently being performed by a contractor? If so, could you please provide the Incumbent name as well as the contract number?**

*Contract Number: N00014-06-D-0045. Vendors: South Carolina Research Authority (SCRA), 91 Technology Drive, Suite 200, Clemson Research Park, Anderson, SC 29625.*

- 12) **In the RFP page 52 of 65 under "Page Size and Format" it states:**

**"Pages should be single spaced, and except for the reproduced section of the solicitation document, the text size should be no less than 12 point in Times New Roman font, with the exception of charts and graphs, which must be in 10-point font or larger."**

- 1) **Can we use 10-point font in tables?**
- 2) **Can Arial font be used in charts, graphs and tables?**

*10-point font may be used in tables. Ariel font may be used in charts, graphs and tables; however it must be in 10-point or larger.*

- 13) **Will the contract allow for issuance of task orders where individual portions of the task order's Statement of Work (SOW) can be priced and carried out using separate CPFF, cost, cost share and/or CPAF structures?**

*Task will generally be issued as, but will not limited to, either a CPFF or CPAF order. It is not anticipated that order will contain combined structures.*

- 14) **Over the 5 year duration of the Navy CMTC Program what percentage of orders (taking into account the total maximum ordering limitation of \$99M) are expected to be issued by the Government on CPFF, cost, cost sharing and CPAF basis?**

*The majority of orders will be issued as CPAF requirements; however, some might be issued as other types of orders including those mentioned above.*

- 15) **What contract type does the Government anticipate will be utilized for award of this effort?**

*The basic contract will be awarded as an Indefinite Delivery / Indefinite Quantity Contract. Tasks will be issued, generally but not limited to, CPFF or CPAF orders.*

- 16) **Where is the Place of Performance?**

*Work under the contract will be conducted at the prime or subcontractors location(s)*

- 17) **Please let me know if there is a due date for RFP question submission, we do not see that stated in the solicitation for the Composites Manufacturing Technology Center effort.**
