Questions shall be submitted in writing by electronic mail. **Questions and responses will be posted at <https://www.onr.navy.mil/02/baa/>**; no other e-mail responses will be provided. Responses will not be made to questions presented by other means, for example, telephone calls and fax messages. No meetings will occur between potential offerors and the Science and Technology Point of Contact. Any questions regarding this solicitation must be provided to the Business Point of Contact listed in this solicitation. Questions must be submitted by 2:00 p.m. EST on 02/20/2007. Questions submitted after this date and time may not be answered and the due date for submission of proposals will not be extended.”

2. Will there be any set-asides for 8 (a), Small Disadvantaged Business, or Women Owned Small Business companies? Are you seeking original 6.1/6.2 or are there opportunities for such funding?

**A:** No. There are no set-asides for 8 (a), Small Disadvantaged Business, or Women Owned Small Businesses. More emphasis will be on 6.1/6.2 funding.

3. Please identify the expected 07 funding for this solicitation. I want to ensure that the PM's/Engineers I have look at this are working towards a funded target.

**A:** Section II entitled "Award Information", on page 16 of the solicitation, lists the information regarding expected funding for FY 07.

4. Part of the requirement for submission – page 18 – is that the cover page must be "signed and dated." Will the electronic signature on Grants.gov be sufficient or do you want five copies of the ink-signed cover sheet sent by snail mail?

**A:** Yes. Electronic signature on Grant.gov is sufficient.

5. There are specific requirements listed for the cover pages of both the technical proposal and the cost proposal yet there is no place to post them. While the cover for the cost proposal can be uploaded with the budget justification, where should the cover for the technical proposal be uploaded.

**A:** The "Attachment" form has been added as an optional form. The cover page for the technical proposal may be uploaded as an "Attachment."

6. On the Grants.gov document, there are two places to upload the technical proposal. One is on the first page -- but there is only the option to upload one document; not two. But on the next page there are upload options for parts of both the Technical Proposal and the Cost Proposal as well as a new section -- REFERENCES SITED -- that was not listed in the 'paper' document. Do you want one file -- Technical proposal AND Cost Proposal -- combined and submitted on the first page and then, in parts, on the second page? Or do you want the upload on page one ignored? And if it is the former, do you want REFERENCES SITED included in the upload. If so, where?

**A:** Offerors are able to submit both the technical and cost proposal separately on the "Attachment" form.

7. Please explain the distinction between a "proposal" and a "grant proposal". Would a "contract proposal" also be submitted through the "grants.gov" site and be required to "use" the grants forms (p. 22). Please clarify.

**A:** When "proposal" is mentioned in the solicitation it refers to any proposal that may be submitted in response to the solicitation (i.e. contract, grant). However, "grant proposal" is specifically referring to a grant proposal and not a contract proposal. A contract proposal would not be submitted through the "grants.gov" site nor will any grant forms be required.

8. Can the submission deadline be extended to March 27, 2007 at 2:00 p.m.?

**A:** No. There will be no extensions to the deadline of February 26, 2007.
