

**Amendment No. 0002
Questions and Answers**

Broad Agency Announcement (BAA) Number 09-023

“Multi Target Track and Terminate (MT3)”

The purpose of Amendment 0002 is to provide additional information in response to BAA Number 09-023.

Question #1 – The Broad Agency Announcement (BAA) states that Phase I will be “no longer than 6 months” and then states “6-9” months. Will the offeror’s at liberty define the duration within the 6-9 months instead 6 months for Phase I?

Answer #1-

-The period of performance for Phase I is for six (6) months. Awards under this BAA will be in the form of cost-plus-fixed fee contracts with a base period and an option period. The period of performance for the base period will be six (6) months and the period of performance for the option period will be for fifty-four (54) months. The base period will cover the Phase I effort. The option period will cover the Phase II effort. The proposals submitted should address all technical issues regarding the two (2) phases of the effort. The proposals submitted should address all technical issues regarding the two (2) phases of the effort. Offerors should submit complete budgets covering both the Phase I and Phase II work. It is anticipated that the option covering Phase II will be exercised on only one of the awarded contracts.

Question #2- The BAA states that the option period will be “51-60” months. Will the offeror’s at liberty shorten the period of Phase II in order to complete the program during FY 2014 (consistent with the BAA’s stated funding profile)?

Answer #2-

-The period of performance for Phase II is for fifty-four (54) months. Awards under this BAA will be in the form of cost-plus-fixed fee contracts with a base period and an option period. The period of performance for the base period will be six (6) months and the period of performance for the option period will be for fifty-four (54) months. The base period will cover the Phase I effort. The option period will cover the Phase II effort. The proposals submitted should address all technical issues regarding the two (2) phases of the effort. The proposals submitted should address all technical issues regarding the two (2) phases of the effort. Offerors should submit complete budgets covering both the Phase I and Phase II work. It is anticipated that the option covering Phase II will be exercised on only one of the awarded contracts.

Question #3- What specific variant of the MH-60 will be used for the program demonstration?

Answer #3- Although the lead platform for this effort is the Fire Scout UAS, it has not been weaponized to date, so the Government expect the MTLD demonstration to be performed from one of the 2 manned SH-60's assigned to Naval Air Warfare Center Weapons Division (NAWCWD) in China Lake, CA

Question #4- Will there be any sensors aboard the MH-60 (MTI, EO/IR/MWIR, etc.) that can be of use to the program, or should the offeror plan on providing sensors?

Answer #4- The Naval Air Warfare Center Weapons Division (NAWC-WD) will be responsible for the weapon system, which will probably be a SAL guided 2.75 inch rocket in the FY 2014 timeframe for the demonstration. The SAL guided rockets will be launched from either a 7 to 19 tube launcher that is already integrated with this platform

Question #5- Will the offeror be responsible for the integration of the sensors onto the MH-60 (including flight certification)?

Answer #5- The Naval Air Warfare Center Weapons Division (NAWC-WD) will integrate the sensor onto the platform, develop a test plan, and execute the testing on the NAWC-WD ranges.

Question #6- Will the offeror be responsible for the integration of the entire Contractor supplied system?

Answer #6- The Naval Air Warfare Center Weapons Division (NAWC-WD) will integrate the entire Contractor system.

Question #7- Can the offeror's visit to present videos that illustrate our capabilities in search, detection, tracking, and targeting?

Answer #7- Due to the restrictions on the BAA is released, the ONR Technical Points of Contact (TPOCs) are not allowed to have any direct interface with potential offerors until the selection process is completed. Each offeror's proposal will have the opportunity to describe and discuss your capabilities in accordance with the BAA.

Question #8- Are telecons precluded even with ONR Contractor moderation?

Answer # 8- Yes, telecons are prohibited.
