ABOUT THIS WORKSHOP

ONR awards primarily cost-type contracts for the preponderance of its requirements due to the absence of precise specifications and difficulties in estimating costs in some of its Research and Development efforts. The Federal Acquisition Regulation Subpart 16.301-3(a)(3) states that a cost-reimbursement contract may be used only when the contractor's accounting system is adequate for determining costs applicable to the contract; firms that do not have an accounting system determined to be adequate may jeopardize their ability to receive a contract.

The acceptability of an accounting system is determined based upon a review performed by the DCAA. Specific information concerning assessing adequacy of a contractor's accounting system may be found at DCAA's website: http://www.dcaa.mil. Please note, only the Government may request a formal DCAA accounting system review.

These workshops will provide targeted information to vendors within the Washington D.C., Maryland, and Virginia commuting area to assist with audit issues that relate to the Small Business community.
